**KWAZISWA BONKE ABATHENGISI KUNYE NABO BENZA USHISHINO NOMASIPALA  
INELSON MANDELA BAY (NMBM)**

Olu nxibelelwano lusebenza ekunikezeleni ngolwazi phakathi kwabo bonke abathengisi kunye nabathengisi abaneenkampani ezithengwa ngeenkqubo ze-NMBM ze-Supply Chain Management (SCM) zokuqhuba ushishino noMasipala.

Kusenokwenzeka ukuba ufunde ngeendlela ezahlukeneyo zonxibelelwano (umz. amaphephandaba) kwiimeko apho i-NMBM isenokuba ilibazise ukulungiswa okanye ukulungiswa kweentlawulo kwiintsuku ezingama-30 ezimiselweyo zokufumana i-invoyisi. Phakathi kwezizathu eziphambili zoku kulibaziseka, kukuba ababoneleli-nkonzo basenokuba bavunyelwe ukuba benze umsebenzi kwiimeko ezithile nto leyo, umzekelo, kungekho ngaphakathi "umda wokuqala womsebenzi" wesivumelwano sokuqala, kwaye ukuba ilungisiwe ngaphandle kokuqhuba ngokufanelekanga iinkqubo zangaphakathi, iya kubangela ukuba kwezizwe "inkcitho engaqhelekanga".

Kufuneka siqaphele ukuba ukwenziwa kwenkcitho engaqhelekanga kuRhulumente weNgingqi akuvumelekanga ngokubhekiselele kuRhulumente weNgingqi: uMthetho woLawulo lweMali kaMasipala (MFMA) (56 ka-2003).

Kwiimeko ezithile, umsebenzi wenziwa ngaphandle kwexesha lesivumelwano esisebenzayo okanye ngaphandle komyalelo wokuthenga osebenzayo, kwakhona kubangela ukuba inkcitho eyenziweyo ibe ngaphandle kweemfuno ze-MFMA, mhlawumbi ihlelwe njengengagunyaziswanga, engaqhelekanga, engenasiqhamo okanye yokuchitha. Zonke ezi ntlobo zenkcitho azivumelekanga ngokwe-MFMA, nto leyo ebangela ukulibaziseka kwenkqubo yokuhlawula njengoko ezinye iinkqubo zangaphakathi **kufuneka** zilandelwe kwiimeko ezinjalo, ngaphambi kokuba kukhutshwe intlawulo.

Ukuba kukho umyalelo wokuba ishishini lakho lenze umsebenzi onokuba ngaphandle komsebenzi wesivumelwano sokuqala, okanye imfuneko yokwandiswa kwesivumelwano sokuqala, kunye nantoni na engaphaya kwesivumelwano sokuqala, **nceda uqinisekise ukuba igunya elifanelekileyo linikwe nguMmeli kaMasipala ogunyazisiweyo ukuze enze njalo.**

[QAPHELA: Ukuba, umzekelo, isivumelwano sakhokuba sokuqala sasinento yokwenza "NokuPeyintwa kwe-Mfanasekhaya Gqobose Building – eseGovan Mbeki Avenue" kwaye ngequbuliso xa ugqibile isabelo /umsebenzi, uyalelwa ukuba upeyinte esinye isakhiwo sikamasipala, nceda uqale ngokubuza malunga nobukho begunya lokwenza njalo, ngaphambi kokuba uqhubeke nomsebenzi onjalo njengoko uya kukhokelela kwingxaki nge-invoyisi yakho / ii-invoyisi zilungiswa ngexesha elifanelekileyo "okanye zingagqitywa konke konke" njengoko leyo yinkcitho eqinisekileyo engaqhelekanga eyenziwe egameni lenkampani yakho].

Ukuqonda intsingiselo yegama elithi "Inkcitho engaqhelekanga" oku kulandelayo kukhutshwa kwiSahluko 1 soRhulumente weNgingqi: uMthetho woLawulo lweMali kaMasipala (56 ka-2003):

"Inkcitho engaqhelekanga", njengoko kuchaziwe kuRhulumente weNgingqi: uMthetho woLawulo lweMali kaMasipala (56 ka-2003), ngokunxulumene nomasipala okanye iqumrhu likamasipala, uthetha:

- (a) incitho eyenziwe ngumasipala okanye iqumrhu likamasipala ngokuchaseneyo, okanye oko akuhambelani, nemfuneko ye-MFMA, nengakhange ivunywe nguNondyabo weSizwe ngokwesiqendu 170;
- (b) incitho eyenziwe ngumasipala okanye iqumrhu likamasipala ngokuchaseneyo, okanye oko akuhambelani, nemfuneko yoMthetho woRhulumente weNgingqi: weeNkqubo zikaMasipala (32 ka-2000), nongakhange uvunywe ngokomthetho;
- (c) incitho eyenziwe ngumasipala ngokuchaseneyo, okanye oko akuhambelani, nemfuneko yoMthetho wabathwali-Ofisi kaRhulumente, ka-1998 (uMthetho Nombolo 20 ka-1998); okanye
- (d) incitho eyenziwe ngumasipala okanye iqumrhu likamasipala ngokuchaseneyo, okanye oko akuhambelani, nemfuneko yomgaqo-nkqubo wolawulo lwekhonkco lokubonelela kamasipala okanye iqumrhu okanye nayiphi na imithetho kamasipala enika ukusebenza komgaqo-nkqubo onjalo, kwaye ongakhange unikwe imvume ngokwemigaqo-nkqubo enjalo okanye umthetho, kodwa ayibandakanyi incitho kamasipala ewela kwinkcazo " yenkcitho engagunyaziswanga".

Ukufumana incitho engaqhelekanga kuneziphumo ezibi njengoko kuqulethwe kwi-MFMA kwaye njengoko kunjalo onke amaqumrhu karhulumente (kubandakanywa noomasipala) awavumelekanga ukuba afumane uhlobo olunjalo lwenkcitho.

Ngoko ke ndiyakubongoza ukuba uqinisekise ukuba xa usenza ushishino ne-NMBM kufuneka, rhoqo, ugcine imigaqo nemiqathango yesivumelwano sokuqala **kunye nomyalelo wokuthenga osebenzayo.**
